8. Chief's Report:

Chief Pruski stated that the bathrooms on the second floor painting is finished with the rubber baseboard has been ordered, the 442 ambulance rear end repairs are complete, the Jeffrey is finished at IVVC, it will be flatbedded over to Todd's Southtown Auto for a belt repair, paramedic Jacob Johns has quit the medic side of the District but will remain on the Fire side, Chris Collins has replaced Jacob, the event Blaze in the City is set to take place on June 30th with a parade and 5B's catering, kids water fights, craft booths, a car and motorcycle show and various vendors, the old abandoned house on West Sandwich road that has had many arson fires has been bought by Aztec, the burn permits have been applied for to assist the new owner with a controlled burn for the house, the IVVC award night was the previous month and Sandwich Inc. awarded the Wasson Scholarship a \$500.00 prize to Joshua Rupp to take Firefighter classes, Scott with MES (Municipal Emergency Services) and Physio will be bringing SCBA's for trial use in July, Assistant Chief Boring conducted an extinguisher training class for Guiding Light Hospice, on June 23rd there will be a Fire Prevention presentation at Wildwood, Assistant Chief met with the DeKalb county building department to discuss the stability of a few bridges in town (weight-bearing etc...), there is also an issue with access to Griswold Springs addresses i.e. the

ambulances do not have adequate clearance, 471 will be back from repair tonight, 481 is at Alexis where 3 cracked welds were found and that repair is under warranty, the Brush truck is at Todd's for a fuel gage repair and Pump Testing will begin on the 26th.
