Deputy Chief Gruca stated that UL was here testing ladders and all of them passed with the exception of 421 as it was in the shop, he is waiting for 1 more speaker for the aerial, there will be no hose testing this year, 442 is still at EVS, 421 is having more work completed, the vehicles are running into more manufacturers shutting down due to Covid therefore parts are taking much longer to obtain.
